I am directed to refer to the Commission's Interim Order No. **Dispute 1 of 2021** dated 02.10.2021 & your letter no. DEL/RLJP/HQ/26/24 dated 23.03.2024 wherein it is requested to allot Symbol to your group during the ongoing General Election to the House of the People.

- 2. Having considered your request, the Commission has allotted the name 'Rashtriya Lok Janshakti Party' for your group and the Symbol 'Sewing Machine' as the symbol to be allotted to the candidate setup, if any, by your group in the current General Elections to the House of the People in all the Parliamentary Constituencies of all the States and Union Territories (except the States of Chhattisgarh, Madhya Pradesh, Maharashtra and Rajasthan).

Further, as the symbol 'Sewing Machine' is already allotted as Common Symbol under para 10B of the Symbols Order, 1968 to other political parties in the States of Chhattisgarh, Madhya Pradesh, Maharashtra and Rajasthan. Therefore, it is requested to kindly furnish a list of at least fifteen (15) symbols from the list of free symbols, immediately, in order to enable the Commission to allot the symbol to the group in the said States.
